O R D E R

On March 24, 2003, Southeast Daviess County Water District (Southeast Daviess) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Southeast Daviess purchases water from Owensboro Municipal Utilities (Owensboro).
2. Owensboro notified Southeast Daviess that effective with its June 1, 2003 billing its wholesale water rate would increase from \$1.148 per 1,000 gallons to \$1.157 per 1,000 gallons. Southeast Daviess proposes to increase the water rates to its customers effective June 1, 2003.
3. During the 12 months ending February 28, 2002, Southeast Daviess purchased 403,038,484 gallons of water from Owensboro and sold 356,530,140 gallons. The increase in the cost of purchased water is \$12,091, resulting in a purchased water adjustment of \$0.01 per 1,000 gallons.
4. The purchased water adjustment of \$0.01 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment of \$0.01 per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after June 1, 2003.
2. The proposed tariff sheets filed by Southeast Daviess are approved as filed.
