ORDER

On April 10, 1991, in Case Nos. 10288-D and 10288-E, the Commission approved the Gas Cost Adjustment ( GCA ) Clause of Auxier Road Gas Company, Inc. ( Auxier ) allowing for the quarterly adjustment of its rates.

On June 2, 2003, Auxier filed its proposed GCA to be effective July 1, 2003. Auxier requests a waiver of the 30-day notice because it did not receive its expected gas rates from its supplier until after June 1, 2003. As KRS 278.180 permits the Commission to shorten the required notice period for good cause, the Commission finds the utility s request should be granted.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Auxier s notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Auxier s Expected Gas Cost ( EGC ) is \$8.7046 per Mcf, 48.65 per Mcf less than the prior EGC of \$9.1911.
3. Auxier s notice sets out no current refund adjustment.
4. Auxier s notice sets out a current quarter actual adjustment ( AA ) of 58.44 cents per Mcf. Auxier s notice includes a total AA of 3.53 cents per Mcf, an increase of 76.42 cents per Mcf from the previous total AA.

5. Auxier's notice sets out a current quarter balance adjustment ( BA ) of 3.9 cents per Mcf. Auxier's notice sets out a total BA of (21.31) cents per Mcf, which is an increase of 10.6 cents per Mcf from the previous total BA.

6. Auxier's gas cost recovery rate is \$8.5268 per Mcf, which is 38.37 cents more than the previous rate of \$8.1431 per Mcf.

7. The rates in the Appendix to this Order are fair, just and reasonable, and should be approved for billing for service rendered by Auxier on and after July 1, 2003.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after July 1, 2003.

2. Within 20 days of the date of this Order, Auxier shall file with this Commission its revised tariffs setting out the rates approved herein.
