ORDER

On December 18, 1991, in Case No. 1991-00138, the Commission approved rates for Natural Energy Utility Corporation (Natural Energy), formerly American Natural Gas Corporation, and provided for their further adjustment in accordance with Natural Energy s gas cost adjustment (GCA).

On June 2, 2003, Natural Energy filed its proposed GCA to be effective July 1, 2003. On June 13, 2003, Natural Energy filed a revised application.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Natural Energy s notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Natural Energy proposed an expected gas cost (EGC) of \$5.9371 per Mcf. Natural Energy incorrectly adjusted its EGC for line loss. Correcting this error produces an EGC of 5.8385, which is 56.33 cents per Mcf less than the previous EGC of \$6.4018.
3. Natural Energy s notice sets out no current quarter supplier refund adjustment (RA). Natural Energy s notice sets out no total RA.

4. Natural Energy's notice sets out a current quarter Actual Adjustment (AA) of \$1.2127 per Mcf. Natural Energy's notice sets out a total AA of \$1.0647 per Mcf. Natural Energy incorrectly carried forward the quarterly AA for one of the previous quarters. Correcting for this results in a total AA of \$1.1597, which is \$1.6802 per Mcf more than the previous total AA.

5. Natural Energy's revised GCA is \$6.9982 per Mcf, which is \$1.1169 per Mcf more than the previous GCA of \$5.8813.

6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Natural Energy on and after July 2, 2003. Natural Energy did not give sufficient notice for rates to be effective July 1, 2003.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Natural Energy are denied.
2. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after July 2, 2003.
3. Within 20 days of the date of this Order, Natural Energy shall file with the Commission its revised tariffs setting out the rates authorized herein.
