ORDER

On September 26, 2003, The Union Light, Heat and Power Company (ULH&P) contacted Commission Staff regarding an informal conference to discuss a possible settlement of the issues in this proceeding. Commission Staff and the parties agreed that a conference should be held on October 15, 2003.

On October 6, 2003, the Attorney General for the Commonwealth of Kentucky (AG) filed a motion requesting that the Commission grant him a one-day extension of time to respond to the data requests propounded to him in this proceeding. The AG states in support of his request that the timing of the informal conference conflicts with his preparation of responses for the data requests which are due October 16, 2003.

The Commission, being sufficiently advised, finds that an informal conference should be scheduled and that the AG s motion should be granted.

IT IS THEREFORE ORDERED that:

1. The AG s motion of October 6, 2003 is granted.

2. An informal conference shall be held on October 15, 2003 at 9:00 a.m., Eastern Daylight Time, in Conference Room 2 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.

3. The procedural schedule established in our August 20, 2003 Order is amended as set forth in Appendix A to this Order.
