ORDER

On June 30, 2003, South Woodford County Water District (South Woodford) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.015 and 807 KAR 5:068.

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. South Woodford purchases water from the city of Versailles (Versailles).
- 2. Versailles notified South Woodford that effective with its May 1, 2003 billing its wholesale water rate would increase from \$1.62 per 1,000 gallons to a four-step declining block rate design with a monthly meter charge of \$2.77. The first step is \$2.10 per 1,000 gallons for the first 75,000 gallons. The second step is \$2.05 per 1,000 gallons for the next 75,000 gallons. The third step is \$2.02 per 1,000 gallons for the next 850,000 gallons. The fourth step is \$2.00 per 1,000 gallons for over 1,000,000 gallons. South Woodford proposes to increase the water rates to its customers effective August 1, 2003.
- 3. During the 12 months ending May 31, 2003, South Woodford purchased 125,087,000 gallons of water from Versailles and sold 118,038,000 gallons. The

increase in the cost of purchased water is \$47,905.30, resulting in a purchased water

adjustment of \$0.41 per 1000 gallons.

4. The purchased water adjustment of \$0.41 per 1,000 gallons is fair, just,

and reasonable and should be approved.

5. South Woodford erred in its calculation of the purchased water adjustment

and failed to account for the \$2.77 meter charge. South Woodford's calculation of a

purchased water adjustment of \$0.39 per 1,000 gallons, therefore, should be denied.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment of \$0.41 per 1,000 gallons and the rates

in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable

and are approved for services rendered on and after August 1, 2003.

2. The purchased water adjustment of \$0.39 per 1,000 gallons, proposed by

South Woodford, is denied.

3. Within 20 days of the date of this Order, South Woodford shall file with the

Commission revised tariff sheets showing the rates approved herein.
