## <u>ORDER</u>

On May 12, 1993, in Case No. 1992-00331, the Commission approved rates for Western Lewis-Rectorville Water and Gas District (Western Lewis) and provided for their further adjustment in accordance with Western Lewiss gas cost adjustment (GCA) clause.

On July 9, 2003, Western Lewis filed its proposed GCA to be effective August 1, 2003. Western Lewis requests a waiver of the 30-day notice period because it did not receive its expected gas rates from its supplier until after July 1, 2003. As KRS 278.180 permits the Commission to shorten the required notice period for good cause, the Commission finds that the request should be granted.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Western Lewis's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Western Lewis s proposed expected gas cost (EGC) is \$6.8122 per Mcf, which is \$1.3083 per Mcf less than the prior EGC of \$8.1205.
  - 3. Western Lewis s notice sets out no refund adjustment.

4. Western Lewis's notice sets out no current quarter actual adjustment

( AA ). Western Lewis s total AA is (33.87) cents per Mcf, which represents no change

from the previous total AA.

5. Western Lewis's notice sets out no current quarter balance adjustment

(BA). Western Lewis s total BA is (28.8) cents per Mcf, which represents no change

from the previous total BA.

6. Western Lewis's gas cost recovery rate is \$6.1855 per Mcf, which is

\$1.3083 per Mcf less than the previous rate of \$7.4938.

7. The rates in the Appendix to this Order are fair, just, and reasonable, and

should be approved for billing for services rendered by Western Lewis on and after

August 1, 2003.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are approved for billing for

services rendered on and after August 1, 2003.

2. Within 20 days of the date of this Order, Western Lewis shall file with this

Commission its revised tariffs setting out the rates authorized herein.
