O R D E R

On March 31, 2000, the Commission issued its Order in Case No. 1999-00225 approving certain adjustments to the rates of Citipower, LLC (Citipower) and providing under certain conditions for the further adjustment of such rates in accordance with the provisions of Citipower s gas cost adjustment (GCA) clause.

On July 23, 2003, Citipower filed its GCA to be effective September 1, 2003.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Citipower s notice proposes revised rates to pass on its expected change in gas costs to its customers.
2. Citipower s proposed expected gas cost (EGC) is \$6.4932 per Mcf, an increase of 42.12 cents per Mcf from the prior EGC of \$6.0720.
3. Citipower s notice sets out no refund adjustment.
4. Citipower s notice sets out a current quarter actual adjustment (AA) of \$1.3996 per Mcf. Citipower s notice sets out a total AA of \$4.0203 per Mcf. Citipower carried forward the incorrect AA from a previous quarter. Correcting for this produces a total AA of \$4.0112, which is an increase of \$1.3996 per Mcf from the previous total AA. This total AA includes a previous quarter AA that will remain in effect for 36 months.

5. Citipower s notice sets out no balance adjustment.

6. These combined adjustments produce a GCA of \$10.5044, which is \$1.8208 per Mcf more than the previous rate of \$8.6836.

7. The revised rates in the Appendix to this Order are fair, just and reasonable, and should be approved for billing for service rendered on and after September 1, 2003.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are fair, just, and reasonable, and are effective for billing for service rendered on and after September 1, 2003.

2. Within 20 days of the date of this Order, Citipower shall file with this Commission its revised tariffs setting out the rates authorized herein.
