O R D E R

On August 13, 2003, the Commission received a letter from Bob Marlowe, Judith Marlowe, and Marlowe Counseling Services, LLC, requesting, among other things, full intervention in this case. In addition, on August 13, 2003, the Commission received letters from Doug Beall, Angela Beall, and Winston Faircloth requesting full intervention in this case.

The Commission will consider these letters as motions for full intervention pursuant to 807 KAR 5:001, Section 3(8). Any materials contained in the motions for intervention will be considered only as grounds in support of the motion for intervention and not as evidence filed in this case. Any party wishing to submit any documents or statements as evidence must comply with Commission regulations for filing evidence.

Marlowe Counseling Services, LLC is a corporate entity. Under Kentucky law, in order to appear and participate in proceedings before the Commission, a corporate entity must be represented by an attorney licensed to practice in Kentucky. As the motion was not signed by an attorney representing Marlowe Counseling Services, LLC, its request for intervention cannot be considered.

The Commission finds that the full intervention of Bob Marlowe, Judith Marlowe, Doug Beall, Angela Beall, and Winston Faircloth is likely to present issues and develop facts that will assist the Commission in fully considering the matter without unduly complicating or disrupting the proceedings. The Commission, being otherwise sufficiently advised, HEREBY ORDERS that:

1. The motion of Marlowe Counseling Services, LLC to intervene is denied without prejudice.

2. The motions of Bob Marlowe, Judith Marlowe, Doug Beall, Angela Beall, and Winston Faircloth to intervene are granted.

3. Bob Marlowe, Judith Marlowe, Doug Beall, Angela Beall, and Winston Faircloth shall each be entitled to the full rights of a party, and shall be served with the Commission's Orders and with filed testimony, exhibits, pleadings, correspondence, and all other documents submitted by the parties after the date of this Order.

4. Should Bob Marlowe, Judith Marlowe, Doug Beall, Angela Beall, or Winston Faircloth file documents of any kind with the Commission in the course of these proceedings, he or she shall also serve a copy of said documents on all other parties of record.
