O R D E R

On August 26, 2003, East Clark County Water District (East Clark) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.012 and 807 KAR 5:068.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. East Clark purchases water from Winchester Municipal Utilities (Winchester).

2. Winchester notified East Clark that effective with its June 1, 2003 billing its water rate would increase from \$1.16 per 100 cubic foot to \$1.18 per 100 cubic foot. East Clark proposes to increase the water rates to its customers effective on and after September 21, 2003.

3. During the 12 months ending May 31, 2003, East Clark purchased 134,515,832 gallons of water and sold 121,900,000 gallons. The increase in the cost of purchased water is \$4,035.00, resulting in a purchased water adjustment of \$0.03 per 1,000 gallons.

4. The purchased water adjustment of \$0.03 per 1,000 gallons is fair, just, and reasonable and should be approved.


IT IS THEREFORE ORDERED that:

1. The proposed rates by East Clark are approved.
2. The purchased water adjustment of \$0.03 per 1,000 gallons and the rates in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after September 21, 2003.
3. Within 20 days of the date of this Order, East Clark shall file with the Commission revised tariff sheets showing the rates approved herein.

The following rates and charges are prescribed for the customers in the area served by East Clark County Water District. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of the Commission prior to the effective date of this Order.

Next	30,000 gallons	8.34 per 1,000 gallons
