O R D E R

On September 3, 2003, Cannonsburg Water District (Cannonsburg) applied for authority to revise certain non-recurring charges. Cannonsburg has provided adequate evidence of the individual expenses incurred to provide the services associated with the proposed charges.

On September 22, 2003, Cannonsburg amended its application to adjust for Unaccounted Water Loss in the Leak Adjustment charge, which raised the charge from \$1.20 to \$1.30 per 1,000 gallons.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. The proposed charges are equal to the expenses incurred to provide the associated services.
2. The charges and policies set forth in the Appendix to this Order are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The charges in the Appendix are approved for services rendered on and after the date of this Order.

2. The revised tariff sheets Cannonsburg filed setting out the proposed rates are approved as filed.
