## ORDER

On November 20, 2000, in Case No. 2000-00158, the Commission approved rates for Burkesville Gas Company, Inc. (Burkesville) and provided for their further adjustment on a quarterly basis in accordance with Burkeville's gas cost adjustment (GCA) clause.

On October 1, 2003, Burkesville filed its proposed GCA to be effective November 1, 2003.

After reviewing the evidence of record and being otherwise sufficiently advised, the Commission finds that:

- 1. Burkesville's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Burkesville's proposed expected gas cost (EGC) is \$9.0094 per Mcf, which is \$1.9469 per Mcf more than the prior EGC of \$7.0625.
  - 3. Burkesville's notice sets out no refund adjustment.
- 4. Burkesville's notice sets out a current actual adjustment (AA) of 12.58 cents per Mcf. Burkesville included an incorrect EGC in its current quarter AA calculation. Correcting for this produces a current quarter AA of 13.5 cents per Mcf.

Burkesville's total AA is also 13.5 cents per Mcf, which is an increase of 26.11 cents per Mcf from the previous total AA.

4. Burkesville's GCA is \$9.1444 per Mcf, which is \$2.208 per Mcf more than the previous rate of \$6.9364.

5. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Burkesville on and after November 1, 2003.

#### IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after November 1, 2003.

2. Within 20 days of the date of this Order, Burkesville shall file with this Commission its revised tariffs setting out the rates authorized herein.
