O R D E R

On October 6, 2003, the Corinth Water District (Corinth) filed an application requesting Commission approval to increase its water rates. The Attorney General and George R. Ignaszak have moved for, and have been granted, full intervention in this proceeding. Therefore, pursuant to KRS 278.190, further proceedings are necessary to determine the reasonableness of Corinth's proposed rates.

IT IS THEREFORE ORDERED that:

1. The procedural schedule set forth in Appendix A to this Order shall be followed.
2. All interrogatories and requests for production of documents shall be appropriately indexed. All responses shall include the name of the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and 6 copies to the Commission.
3. At any hearing in this matter neither opening statements nor summarization of direct testimony shall be permitted.
4. Motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.

5. All documents that this Order requires to be filed with the Commission shall be served upon all other parties.

6. Service of any document or pleading shall be made in accordance with Administrative Regulation 807 KAR 5:001, Section 3(7), and Kentucky Civil Rule 5:02.

7. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
