ORDER

On October 22, 2003, in Case No. 2003-00141, the Commission approved rates for Mike Little Gas Company, Inc. (Mike Little), and provided for their further adjustment in accordance with Mike Little s gas cost adjustment (GCA) clause.

On November 10, 2003, Mike Little filed its proposed interim GCA to be effective December 1, 2003. Mike Little requests a waiver of the normal 30-day notice period in order to request a new rate from one of its suppliers, which became effective November 1, 2003. As KRS 278.180 permits the Commission to shorten the required notice period for good cause, the Commission finds the request should be granted.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Mike Little s notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Mike Little s EGC is \$8.2576 per Mcf, which is an increase of \$1.2182 per Mcf from the previous EGC of \$7.0394.
3. Mike Little s notice sets out no current quarter refund adjustment (RA), and it had no RAs remaining from previous quarters.

4. Mike Little s notice sets out no current quarter actual adjustment (AA).
Mike Little s notice sets out a total AA of (8.2) cents per Mcf, which is no change from the previous total AA.

5. Mike Little s GCA is \$8.1756 per Mcf, which is \$1.2182 per Mcf more than the previous rate of \$6.9574.

6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Mike Little on and after December 1, 2003.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after December 1, 2003.

2. Within 20 days of the date of this Order, Mike Little shall file with this Commission its revised tariffs setting out the rates authorized herein.
