ORDER

On December 5, 2003, Christian County Water District (Christian District) submitted an application for a Certificate of Public Convenience and Necessity to construct, finance, and increase rates for a \$2,000,000 waterworks improvement project. The project consists of the construction of a 200,000-gallon elevated water storage tank with appurtenances on Old Haley's Mill Road in the Apex area; an upgrade to the telemetry system; construction of a booster pump station; and installation of approximately 18 miles of 4-inch and 6-inch water distribution lines and appurtenances to serve 87 potential customers in the Apex area.

Christian District proposes to finance the construction of the project through the issuance of United States Department of Agriculture ("USDA"), Rural Development (RD) Water System Revenue Bond in the amount of \$400,000; an RD Grant in the amount of \$600,000; and a Kentucky Infrastructure Authority Fund B grant in the amount of \$1,000,000. Christian District has a commitment from RD to purchase said \$400,000 of bonds maturing over a 40-year period, at an interest rate not exceeding 4.625 percent per annum.

Christian District's application was made pursuant to KRS 278.023, which requires the Commission to accept agreements between water utilities and the USDA or the U.S. Department of Housing and Urban Development and to issue the necessary orders to implement the terms of such agreements within 30 days of satisfactory completion of the minimum filing requirements. Given that minimum filing requirements were met in this case on December 5, 2003, KRS 278.023 does not grant the Commission any discretionary authority to modify or reject any portion of this agreement.

IT IS THEREFORE ORDERED that:

- Christian District is granted a Certificate of Public Convenience and Necessity for the proposed construction project.
 - 2. Christian District's proposed plan of financing with RD is accepted.
- 3. Christian District is authorized to issue Water System Revenue Bonds, in the amount of \$400,000 maturing over 40 years and at an interest rate not exceeding 4.625 percent per annum.
- 4. Christian District shall file a copy of the as-built drawings and a certified statement that the construction has been satisfactorily completed in accordance with the contract plans and specifications within 60 days of the substantial completion of the construction certificated herein.
- 5. Christian District shall notify the Commission one week prior to the actual start of construction and at the 50 percent completion point.

6. Three years from the effective date of this Order, Christian District shall

file an income statement, along with any pro forma adjustments, in sufficient detail to

demonstrate that the proposed water rates are sufficient to meet its operating expenses

and annual debt service requirements.

7. Christian District shall monitor the adequacies of the expanded water

distribution system after construction. If the level of service is inadequate or declining or

the pressure to any customer is outside the requirements of Administrative Regulation

807 KAR 5:066, Section 5(1), Christian District shall take immediate action to maintain

the level of service in conformance with the regulations of the Commission.

8. The rates set out in Appendix A, which is attached hereto and

incorporated herein, are the rates approved for service rendered on and after the date

of this Order.

Nothing contained herein shall be deemed a warranty of the Commonwealth of

Kentucky, or any agency thereof, of the financing herein accepted.
