ORDER

On April 21, 2003, East Clark County Water District (“East Clark District”) applied for a Certificate of Public Convenience and Necessity (“Certificate”) to construct a \$902,736 waterworks improvement project and for approval of its plan for financing the project. On May 28, 2003, East Clark District was granted a Certificate to proceed with the construction of approximately 13.25 miles of 4-inch and 6-inch water lines, installation of two new master meter connections to the Winchester Municipal Utilities, installation of a new master meter connection to Kentucky-American Water Company, and upgrade of the booster pump on Bailey Lane. The Commission approved a \$264,000 loan from Kentucky Rural Water Finance Corporation with a 10-year term between 1.45 to 4.16 percent per annum variable interest rate. On August 28, 2003, East Clark District was granted a Certificate to proceed with the additional construction of 2,954 linear feet of 4-inch PVC water transmission mains and related appurtenances

to service two additional customers at the end of Lillies Ferry Road at a cost of \$26,739.29.

On June 9, 2004, East Clark District requested approval to construct approximately 2,300 linear feet of additional 4-inch PVC water transmission main and related appurtenances not included in the previous two Orders. This additional project will add two new customers along KY 646 – Nest Egg Road at a cost of approximately \$34,950.32. This extension will be funded from existing contingency money or from internally generated funds. Plans and specifications for the proposed extension prepared by Howard K. Bell Consulting Engineers, Inc. of Lexington, Kentucky, were approved on April 8, 2004 by the Division of Water of the Environmental and Public Protection Cabinet.

The Commission, having reviewed the evidence of record and being otherwise sufficiently advised, finds that:

1. Public convenience and necessity require that the requested additional construction proposed be performed and that a Certificate be granted.
2. The proposed additional construction consists of approximately 2,300 linear feet of 4-inch PVC water transmission main and related appurtenances along KY 646 – Nest Egg Road.
3. East Clark District should notify the Commission prior to performing any additional construction not expressly authorized by this Order, the August 28, 2003 Order, or the May 28, 2003 Order.
4. Any deviation from the construction approved should be undertaken only with the prior approval of the Commission.

5. East Clark District should furnish documentation of the total costs of this project including the cost of construction and all other capitalized costs (engineering, legal, administrative, etc.) within 60 days of the date that construction is substantially completed. Construction costs should be classified into appropriate plant accounts in accordance with the Uniform System of Accounts for water utilities prescribed by the Commission.

6. East Clark District should require construction to be inspected under the general supervision of a licensed professional engineer with a Kentucky licensure, competent in civil or mechanical engineering, to ensure that the construction work is done in accordance with the contract drawings and specifications and in conformance with the best practices of the construction trades involved in the project.

IT IS THEREFORE ORDERED that:

1. East Clark District is granted a Certificate to proceed with the proposed construction project consisting of approximately 2,300 linear feet of 4-inch PVC water transmission main and related appurtenances as set forth in the drawings and specifications of record herein.

2. East Clark is authorized to use the proceeds from its loan of \$264,000 from the Kentucky Rural Water Finance Corporation for the additional construction project.

3. East Clark District shall comply with the requirements contained in Findings 3 through 6 as if the same were individually so ordered.
