<u>ORDER</u>

By Order dated July 17, 2003, the Commission initiated this investigation of the membership of Louisville Gas and Electric Company ("LG&E") and Kentucky Utilities Company ("KU") in the Midwest Independent Transmission System Operator, Inc. ("MISO"). A number of issues were specifically identified for review in this case, including the costs and benefits to LG&E and KU of membership in MISO and the feasibility of LG&E and KU joining a southern Regional Transmission Organization ("RTO").

Since opening this case, a substantial evidentiary record has been created through discovery, prepared testimony, and two public hearings: one on February 25, 2004; the other on April 8, 2004. Subsequent to the last public hearing, MISO filed with the Federal Energy Regulatory Commission new tariffs to establish day-ahead and real-time energy markets. Due to the timing of the filing of these new MISO tariffs, their impact on the costs and benefits of MISO membership has not been subject to examination and review in this proceeding.

In addition, while LG&E and KU did address the issue of joining a southern RTO, the Commission finds that it may have defined this issue too narrowly. Based on the Commission's recent authorization of Kentucky Power Company d/b/a American Electric Power to join the PJM Interconnection, L.L.C. ("PJM") RTO, LG&E and KU should have an opportunity to address the feasibility of joining PJM, or any other RTO, irrespective of its geographic boundaries.

To ensure that the evidentiary record in this case is fully developed, the Commission finds that LG&E and KU should file supplemental testimony addressing the energy market tariffs that have been filed recently by MISO, as well as the feasibility, including costs and benefits, of joining PJM or any other RTO. The procedural schedule set forth in Appendix A will allow the record to be supplemented on these issues.

IT IS THEREFORE ORDERED that:

- 1. The evidentiary record in this case is reopened and the procedural schedule set forth in Appendix A hereto shall be followed.
- 2. LG&E and KU shall file testimony in accordance with the attached procedural schedule on the issues discussed in the findings above.
