O R D E R

On September 22, 2004, the Midwest Independent Transmission System Operator, Inc. ("MISO") filed a motion requesting a partial extension of the procedural schedule appended to the Commission's August 19, 2004 Order. Specifically, MISO states that it has reached an agreement with Louisville Gas and Electric Company ("LG&E") and Kentucky Utilities Company ("KU") that the due date for their respective supplemental direct testimonies will be extended by one week, and that data requests served by the Office of the Attorney General ("AG"), Kentucky Industrial Utility Customers, Inc. ("KIUC"), and Commission Staff also will be extended one week, and that the responses thereto will be extended by six additional days. The motion further states that MISO and LG&E/KU have agreed that their respective data requests to each other and the responses thereto will still be filed as required under the existing procedural schedule, and all other procedural events will be in accordance with the existing procedural schedule.

Based on the motion and being otherwise sufficiently advised, the Commission finds good cause to modify the procedural schedule as requested.

IT IS THEREFORE ORDERED that the procedural schedule appended to the August 19, 2004 Order is modified to the limited extent as provided in Appendix A, attached hereto, and all other procedural events and dates set forth in the August 19, 2004 Order shall remain in full force and effect.

from the AG, KIUC, and Commission Staff no later than..... 10/26/04
