O R D E R

On December 11, 2003, Beech Grove Water System ("Beech Grove") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.012 and 807 KAR 5:068. The application was found to be deficient. As the deficiencies were cured on January 20, 2004, the application is considered filed as of this date.

Henderson Water Utility ("Henderson"), a municipal water system, filed with the Commission its request for approval of its wholesale rate on January 29, 2004. West Daviess County Water District ("West Daviess") applied to the Commission to raise its wholesale rate in Case No. 2003-00113.<sup>1</sup> The rate increase was approved by Order dated May 13, 2003.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Beech Grove purchases water from Henderson and West Daviess.
2. Henderson notified Beech Grove that, effective with its March 2004 consumption, its wholesale water rate would increase from \$2.32 per thousand gallons

to \$2.67 per thousand gallons. West Daviess notified Beech Grove that, effective with its July 2003 consumption, its wholesale water rate would increase from \$1.91 per thousand gallons to \$1.94 per thousand gallons. Beech Grove proposes to increase the water rates to its customers effective with the date of this Order.

3. During the 12 months ending December 31, 2003, Beech Grove purchased 47,171,649 gallons of water from Henderson and 14,681,000 gallons of water from West Daviess. During the same period, it sold 48,789,154 gallons. The increase in the cost of purchased water is \$16,951, resulting in a purchased water adjustment of \$0.35 per 1000 gallons. Based on an average monthly usage of 5,000 gallons, the average bill of Beech Grove's customers would rise \$1.75 from \$28.44 to \$30.19 or 6.2 percent.

4. The purchased water adjustment of \$0.35 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment of \$0.35 per 1,000 gallons is fair, just, and reasonable.


2. Upon Commission approval of Henderson's wholesale rate, the retail rates for Beech Grove in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after March 1, 2004.

3. Within 20 days of the date of this Order, Beech Grove shall file with the Commission revised tariff sheets showing the rates approved herein.
