#### SOUTHEAST TELEPHONE'S MOTION TO COMPEL

Comes now Southeast Telephone Company ("SouthEast Telephone"), by and through counsel and hereby moves this Honorable Commission to compel lawful obedience to its orders entered in this case as to Kentucky ALLTEL, Inc.'s ("ALLTEL") duty to provide unbundled network elements, including local switching, interconnection and services to SouthEast Telephone.

#### HISTORY

In support of this Motion, SouthEast Telephone states that on December 19, 2003, this Commission entered an Order settling the disputed terms of an Interconnection Agreement between SouthEast Telephone and ALLTEL. The Commission once again entered an Order on February 6, 2004, resolving additional disputed items that were not anticipated by the parties in the original arbitration. Finally, this Commission entered an Order on March 5, 2004, denying ALLTEL's petition for reconsideration in this matter, taking into consideration all recent developments at the F.C.C. and in Federal Court. Despite this Commission's well-reasoned Orders, ALLTEL has refused, and continues to refuse to process any of SouthEast Telephone's orders for service.

#### **FACTS**

On March 12, 2004, SouthEast Telephone faxed to ALLTEL several the paperwork necessary to provision customer orders (See Attached). After discussions between the officers of SouthEast Telephone and ALLTEL, SouthEast sought intervention of counsel. Undersigned counsel contacted ALLTEL and was informed that the company did not intend on processing any orders for service from SouthEast Telephone, despite the three (3) Commission Orders to the contrary and despite their obligations under state and federal law.

#### ARGUMENT AND PETITIONS FOR RELIEF

Pursuant to K.R.S. 278.390, this Commission is empowered to "compel obedience to its lawful orders by mandamus, injunction or other proper proceedings in the Franklin Circuit Court or any other court of competent jurisdiction, and such proceedings shall have priority over all pending cases." SouthEast Telephone hereby petitions this Commission to institute any and all proceedings necessary to compel ALLTEL to simply comply with the Commission's lawful Orders.

ALLTEL's blatant refusal to comply with the Commission's Orders violates not only its duty to negotiate in good faith pursuant to 47 U.S.C. §252(b)(5), but also violates K.R.S. 278.170, which prohibits discriminatory conduct as to rates and services by a utility.

The pertinent Federal statute, 47 U.S.C. §252(b)(5) reads as follows:

The refusal of any other party to the negotiation to participate further in the negotiations, to cooperate with the State commission in carrying out its function as an arbitrator, or to continue to negotiate in good faith in the presence, or with the assistance, of the State commission shall be considered a failure to negotiate in good faith.

In addition, Kentucky law prohibits any utility from subjecting "any person to any unreasonable prejudice or disadvantage" as to rates or service. K.R.S. 278.170.

ALLTEL has violated these statutory provisions, and has indicated in no uncertain terms that it intends to continue to violate these statutory provisions because it simply does not agree with the Commission's stance in this case.

SouthEast Telephone hereby petitions this Commission to make a finding that ALLTEL has violated both K.R.S. 278.170 as well as 47 U.S.C. §252(b)(5) in its failure to provide service pursuant to this Commission's Orders and ALLTEL's obligations under the 1996 Telecommunications Act.

In addition to these remedies, SouthEast Telephone petitions this Commission to levy any and all appropriate penalties against ALLTEL pursuant to K.R.S. 278.990, including monetary fines and revocation of ALLTEL's privilege to conduct business in this Commonwealth should it continue to refuse to process SouthEast Telephone's orders for service.
