ORDER

On October 24, 2003, in Case No. 2003-00171, the Commission approved rates for Elam Utility Company ("Elam") and provided for their further adjustment on a quarterly basis in accordance with Elam's gas cost adjustment ("GCA") clause.¹

On May 28, 2004, Elam filed its proposed GCA to be effective July 1, 2004.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Elam's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Elam's Expected Gas Cost ("EGC") is \$7.3403, which is 1.31 cent per Mcf less than the previously approved EGC of \$7.3534.
 - 3. Elam's notice sets out no current refund adjustment.
- 4. Elam's notice sets out a current quarter actual adjustment ("AA") of 6.52 cents per Mcf. Elam included January and February 2004 in its calculation, which it had already included in the AA calculation in its last GCA filing. Elam also used an incorrect

EGC in its calculation for March 2004. Correcting for these errors produces a current

quarter AA of (8.36) cents per Mcf. Elam's total AA is 37.62 cents per Mcf, which is a

decrease of 8.36 cents from the previous total AA.

5. Elam's notice sets out no current quarter balance adjustment ("BA").

Elam's notice sets out no total BA. Elam has a previous quarter BA of (62.5) cents per

Mcf that should be carried forward. Elam's total BA is (62.5) cents per Mcf, which is no

change from the previous total BA.

6. Elam's revised GCA is \$7.0915 per Mcf, which is 9.67 cents per Mcf less

than the previous GCA of \$7.1882.

7. The rates in the Appendix to this Order are fair, just and reasonable, and

should be approved for billing for service rendered by Elam on and after July 1, 2004.

IT IS THEREFORE ORDERED that:

1. Elam's proposed rates are denied.

2. The rates in the Appendix to this Order are approved for billing for service

rendered on and after July 1, 2004.

3. Within 20 days of the date of this Order, Elam shall file with this

Commission its revised tariff sheets setting out the rates authorized herein.
