ORDER

On June 18, 2004, Northeast Woodford County Water District ("Northeast Woodford") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure. KRS 278.012 and 807 KAR 5:068.

The city of Versailles ("Versailles"), a municipal water system, notified Northeast Woodford that, effective with its June 10, 2004 meter reading, its wholesale water rate would increase from \$2.00 per 1,000 gallons to a meter charge and declining block rate structure.

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Northeast Woodford purchases water from Versailles.
- Versailles notified Northeast Woodford that, effective with its June 10,
 meter reading, its wholesale water rate would increase from \$2.00 per 1,000
 gallons to a meter charge and declining block rate structure.
- 3. During the 12 months ending April 2004, Northeast Woodford purchased 145,757,000 gallons of water from Versailles and sold 115,943,000 gallons. The

increase in the cost of purchased water is \$3,048, resulting in a purchased water adjustment of \$0.03 per 1,000 gallons. Based on an average monthly usage of 5,000 gallons, the customer's monthly bill will increase \$0.15 from \$22.55 to \$22.70 or 0.67 percent.

4. The purchased water adjustment of \$0.03 per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

- 1. The purchased water adjustment of \$0.03 per 1,000 gallons is approved.
- 2. The retail rates for Northeast Woodford in Appendix A, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after July 31, 2004.
- 3. The proposed tariff sheets filed by Northeast Woodford are approved as filed.
