O R D E R

On June 25, 2004, Powell's Valley Water District ("Powell's Valley") applied for authority to revise certain non-recurring charges. Powell's Valley was notified on July 2, 2004 that the filing was deficient. On July 28, 2004, Powell's Valley filed information that cured the deficiencies and the application was considered filed. Powell's Valley has provided adequate evidence of the individual expenses incurred to provide the services associated with the proposed non-recurring charges.

Powell's Valley also included in its filing proposed adjustments in its deposit requirements for service for its 5/8" x 3/4" meter, 3/4" meter, and 1" meter sets to \$70.00. However, the published notice given by Powell's Valley to its customers and as filed on July 28, 2004 with the Commission, lists the proposed charge at \$60.00 for those meters. Powell's Valley's filed tariff presently contains a meter deposit for the 5/8" x 3/4" meter, 3/4" meter, and 1" meter sets of \$60.00.

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. The proposed non-recurring charges are equal to the expenses incurred to provide the associated services.

2. As notice of the proposed deposit amount of \$70.00 was not published as Administrative Regulation 807 KAR 5:011 required, it should be denied.

3. The charges and policies set forth in the Appendix to this Order are fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The charges in the Appendix are approved for services rendered on and after the date of this Order.

2. The proposed deposit amount of \$70.00 is denied.

3. The proposed tariff sheets filed by Powell's Valley are accepted as filed.
