ORDER

On January 31, 2002, in Case No. 2001-00092, the Commission approved rates for The Union Light, Heat and Power Company ("ULH&P") and provided for their further adjustment in accordance with ULH&P's gas cost adjustment ("GCA") clause.¹

On August 10, 2004, ULH&P filed its GCA to be effective August 30, 2004. ULH&P previously obtained Commission approval to file its GCA within 20 days of the proposed effective date.²

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. ULH&P's notice includes rates designed to pass on to its customers its expected change in wholesale gas costs.

- 2. ULH&P's Expected Gas Cost ("EGC") is \$6.653 per Mcf, which is a decrease of 45 cents per Mcf from the previous EGC of \$7.103.
- 3. ULH&P's notice sets out a current refund adjustment ("RA") of (.1) cent per Mcf. The total RA of (.1) cent per Mcf represents an increase of .3 cent per Mcf from the previous total RA.
- 4. ULH&P's notice sets out a current quarter actual adjustment ("AA") of (32) cents per Mcf. The total AA of 12.6 cents per Mcf represents a decrease of 13.7 cents per Mcf from the previous total AA.
- 5. ULH&P's notice sets out a current quarter balancing adjustment ("BA") of 2.3 cents per Mcf. The total BA of (.9) cent per Mcf represents a decrease of .6 cent per Mcf from the previous total BA.
- 6. ULH&P's gas cost recovery rate ("GCR") is \$6.769 per Mcf, which is 59 cents per Mcf less than its previous GCR of \$7.359.
- 7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by ULH&P on and after August 30, 2004.

IT IS THEREFORE ORDERED that:

- 1. The rates in the Appendix to this Order are approved for final meter readings on and after August 30, 2004.
- 2. Within 20 days from the date of this Order, ULH&P shall file with this Commission its revised tariffs setting out the rates authorized herein.
