ORDER

On November 15, 2004, Big Rivers Electric Corporation ("Big Rivers") filed an application for Commission approval of the construction of a transmission line in Breckinridge and Meade counties, Kentucky. Pursuant to KRS 278.020(8), "The commission shall issue its decision no later than ninety (90) days after the application is filed, unless the commission extends this period for good cause, to one hundred twenty (120) days."

The Commission finds that such an extension is warranted in this case. Big Rivers' need for the line as proposed will be an issue in this case, and the Commission has therefore employed the services of a consulting firm to issue a report on that subject. The Commission and the parties will need time to study this report and should be allowed the opportunity for discovery and evidentiary hearings, both of which would extend the time the Commission needs to process the application. For this reason, the Commission finds that the time period in which it must issue a decision in this case should be extended to 120 days.

To ensure that all parties have an opportunity to participate fully in this proceeding, the Commission established a procedural schedule, attached hereto as Appendix A, based on this extended time period.

IT IS THEREFORE ORDERED that:

- 1. The time period in which the Commission must issue its decision in this case is extended to 120 days, or March 15, 2005.
 - 2. The attached procedural schedule shall apply.
