O R D E R

On March 31, 2000, the Commission issued its Order in Case No. 1999-00225¹ approving certain adjustments to the rates of Citipower, LLC (“Citipower”) and providing under certain conditions for the further adjustment of such rates in accordance with the provisions of Citipower’s gas cost adjustment (“GCA”) clause.

On November 1, 2004, Citipower filed its GCA to be effective December 1, 2004.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Citipower’s notice proposes revised rates to pass on its expected change in gas costs to its customers.
2. Citipower’s proposed expected gas cost (“EGC”) is \$9.5240 per Mcf, an increase of \$2.538 per Mcf from the prior EGC of \$6.9860.
3. Citipower’s notice sets out no refund adjustment.
4. Citipower’s notice sets out a current quarter actual adjustment (“AA”) of 4.95 cents per Mcf. Citipower’s notice sets out a total AA of \$1.6111 per Mcf, which is a

decrease of 5.42 per Mcf from the previous total AA. This total AA includes a previous quarter AA that will remain in effect until September 2005.²

5. Citipower's notice sets out a current quarter balance adjustment ("BA") of (35.91) cents per Mcf. Citipower's notices sets out a total BA of (\$1.3619) per Mcf, which is a decrease of 35.91 cents per Mcf from the previous total BA.

6. These combined adjustments produce a GCA of \$9.7732, which is \$2.1247 per Mcf more than the previous rate of \$7.6485.

7. The revised rates in the Appendix to this Order are fair, just and reasonable, and should be approved for billing for service rendered on and after December 1, 2004.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are fair, just, and reasonable, and are effective for billing for service rendered on and after December 1, 2004.

2. Within 20 days of the date of this Order, Citipower shall file with this Commission its revised tariffs setting out the rates authorized herein.

The following rates and charges are prescribed for the customers served by Citipower, LLC. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of this Commission prior to the effective date of this Order.
