<u>ORDER</u>

On January 31, 2002, in Case No. 2001-00092, the Commission approved rates for The Union Light, Heat and Power Company ("ULH&P") and provided for their further adjustment in accordance with ULH&P's gas cost adjustment ("GCA") clause.¹

On December 9, 2004, ULH&P filed its GCA to be effective January 3, 2005. ULH&P previously obtained Commission approval to file its GCA within 20 days of the proposed effective date.²

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. ULH&P's notice includes rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. ULH&P's Expected Gas Cost ("EGC") is \$7.611 per Mcf, which is a decrease of 79.7 cents per Mcf from the previous EGC of \$8.408.
- 3. ULH&P's notice sets out no current refund adjustment ("RA"). The total RA of (.1) cent per Mcf represents no change from the previous total RA.

4. ULH&P's notice sets out no current quarter actual adjustment ("AA"). The total AA of 12.6 cents per Mcf represents no change from the previous total AA.

5. ULH&P's notice sets out no current quarter balancing adjustment ("BA"). The total BA of 0 cent per Mcf represents no change from the previous total BA.

6. ULH&P's gas cost recovery rate ("GCR") is \$7.736 per Mcf, which is 79.7 cents per Mcf less than its previous GCR of \$8.533.

7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by ULH&P on and after January 3, 2005.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are approved for final meter readings on and after January 3, 2005.

2. Within 20 days from the date of this Order, ULH&P shall file with this Commission its revised tariffs setting out the rates authorized herein.
