## ATTACHMENT

Georgia A. Basham vs. Momentum Telecom

When I noticed that my long distance was not working, I called Momentum Telecom to see why. I asked for a supervisor and spoke with Steve Patterson. He explained to me that my computer modem had been hijacked by Saotome dialer, making 509 international calls beginning 10-22-04 at 11:29 PM and ending 10-23-04 at 1:29 PM. The number that was dialed every minute to every two minutes or so was 239-0000203587 to a country called Saotome. This resulted in long distance charges of \$2120.48 plus taxes to my account. My total phone bill is \$2524.66, my regular phone bill is only \$35 for 11-19-04 thru 12-18-04, which I am paying with a check on 11-29-04.

I did not make any of these calls and do not feel responsible for them.

Mr. Patterson did say Momentum would accept 25% of the total bill which would be \$654.00, which is not reflected in my statement. However, I still do not feel I should be responsible for any amount of money associated with these international calls placed without my knowledge or consent.
