ORDER

Butler County Water System, Inc., Simpson County Water District, and Warren County Water District have moved for clarification of the Commission's Order of March 29, 2005. More specifically, they have inquired as to whether the Commission's Order applies to service sizes not expressly listed in the Order.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that our Order of March 29, 2005 failed to specify fire protection rates for certain service sizes and should be amended to include fire protection rates for these service sizes. We further find that the Order should be amended to require the water utilities to file annually a report of the total number of customers who are currently receiving fire protection service and the number of customers for each service size who are currently receiving fire protection service.

IT IS THEREFORE ORDERED that:

1. Butler County Water System, Inc. shall, for fire protection service rendered on and after the date of this Order, charge the rates set forth in Appendix A of this Order.

2. Simpson County Water District shall, for fire protection service rendered on and after the date of this Order, charge the rates set forth in Appendix B of this Order.

3. Warren County Water District shall, for fire protection service rendered on and after the date of this Order, charge the rates set forth in Appendix C of this Order.

4. Beginning for Calendar Year 2005, each of the water utilities shall file with the annual and statistical report required by Administrative Regulation 807 KAR 5:006, Section 3, a written report of the total number of customers who are receiving fire protection service on December 31 of the reporting year and the total number of customers for each service size who are receiving such service.
