O R D E R

On February 14, 2005, the Midwest Independent Transmission System Operator, Inc. ("MISO") filed a motion for an extension of the procedural schedule to allow it an additional 7 days to file its additional rebuttal testimony. The current procedural schedule, appended to the Commission's February 4, 2005 Order, established February 14, 2005 as the last date for MISO to file its additional rebuttal testimony. MISO states that it has made a diligent and good faith effort to complete its additional cost/benefit analysis in time to file that analysis and its additional rebuttal testimony by February 14, 2005, but that MISO has been unable to complete its review process and anticipates needing an additional 7 days.

On February 16, 2005, Louisville Gas and Electric Company ("LG&E") and Kentucky Utilities Company ("KU") filed a response in objection to MISO's request for an extension of time. The response also states that if MISO's request for an extension of time is granted, the procedural schedule should be modified to provide for one round of discovery to MISO prior to the filing of additional supplemental rebuttal testimony by

LG&E and KU. The response further requests that the hearing, which is now scheduled on March 1, 2005, be rescheduled to March 23, 2005.

Based on the motion and being otherwise sufficiently advised, the Commission finds that MISO's motion should be granted and that the procedural schedule appended to our February 4, 2005 Order should be superseded by the schedule set forth in Appendix A attached hereto.

IT IS THEREFORE ORDERED that MISO's motion for an extension of time is granted and the procedural schedule set forth in Appendix A attached hereto shall be followed in this case.
