1	The sworn statement of WILLIAM H.
2	JONES, JR., taken telephonically in the offices of
3	the Public Service Commission, 211 Sower Boulevard,
4	Frankfort, Kentucky, on Wednesday, the 27th day of
5	July, 2005, at approximately 11:30 a.m.
6	
7	EXAMINATION
8	
9	BY MR. GOLDBERG:
10	Q. Could you state your full name,
11	please.
12	A. William H. Jones, Jr.
13	Q. Okay. And your address, your business
14	address?
15	A. 1544 Winchester Avenue, Ashland,
16	Kentucky, 41101.
17	Q. All right, sir. And what is your
18	occupation?
19	A. I'm an attorney.
20	Q. Okay. And are you employed by a firm
21	or are you a sole practitioner?
22	A. I am with the firm of VanAntwerp,
23	Monge, Jones and Edwards.
24	Q. Okay. And I trust the address you
25	gave us is the address of the firm.

1 Α. Right. 2 And how long have you been employed Q. 3 there, sir? 4 Ά. Since 1972. 5 Q. All right, sir. And do you have a 6 particular area of expertise that you practice in? 7 Α. I practice environmental law and 8 commercial law, primarily representing steel 9 manufacturers. 10 All right, sir. Are you familiar with Q., 11 a company by the name of North American Stainless? 12 Α. Tam. 13 And do you represent North American Ο. 14 Stainless? 15Α. I do. 16 Q. And how long have you represented 17 North American Stainless? Since the early '90s. 18 Α. All right, sir. And what type of work 19 Ο. 20 do you perform, legal work, for North American 21 Stainless? 22 Environmental, commercial, corporate. Α. 23 And then our firm also -- and I participate to a 24 lesser degree with litigation matters. 25 Q. All right, sir. Are you familiar with

an operation they have in Ghent, Kentucky? 1 2 Α. I am. 3 Ο, Okay. And do I take it you do legal work for that particular operation? 4 Α. 5 Yes. Okay. With regard to that operation, 6 Ο. whom do you directly work with? 7 8 Α. Well, I report to Mary Jean Riley, the 9 vice president of administration. But I'm sure you 10 understand I've worked with many different people at 11 North American Stainless, including the general 12 counsel, Nat Adams, and others. 13 Q . Okay. The person I was looking for is Nat Adams. 14 I take it that you do work with him from 15time to time? 16 Α. I do. 17 Q. Okay. Did you become familiar with an 18 issue as far as North American Stainless was 19 concerned dealing with a tariff involving KU sometime 20 in the year 2003? 21 Α. By tariff, are you referring to the tariff that was -- that was filed by KU years ago, or 22 23 are you referring to their nonconforming load service 24 tariff that they've subsequently filed? 25 Ο. I'm referring to the tariff which --

1 the older of the two, which it's my understanding 2 North American Stainless was operating under and unhappy with. And again, my time period here is 3 sometime second quarter of 2003. Δ So --Α. Let me --5 6 Ο. Go ahead, sir. 7 Α. Let me explain. North American 8 Stainless did operate its stainless steel production and received service under the LCI-TOD tariff and 9 continues to receive service under that tariff for 10 11 much of its operations. However, when North American 12 Stainless invested in a melt shop, and in particular sought to install an electric arc furnace, then by 13 virtue of the LCI-TOD tariff provision, because the 14 15 load would be more than 50 megawatts, it was required 16 to negotiate a special contract with KU. And that 17 special contract was entered into I believe in 18 July 2000. It was that contract I suppose you're 19 referencing that --20 Q. Yes, sir. 21 Α. -- North American Stainless became 22 concerned that the rates were not fair, just and 23 reasonable. It did not question the LCI-TOD rates. 24 Fair enough. Were you employed to Q.. 25 deal with those issues for North American Stainless?

1 Α. Yes. 2 Q. Okay. And what course of action did 3 you take as it relates to the PSC? 4 Α. As it relates to the PSC? 5 Ο. Yes, sir. 6 Α. We -- as I recall, NAS was having discussions with KU about the contract. There were 7 8 two issues, whether the contract would be 9 renegotiated or whether the contract would be renewed. I believe it was scheduled to expire in 10 March of 2004. We did have discussions with the PSC 11 12 concerning the procedures for review of the contract 13 and/or the establishment of rates if the contract 14 were not renewed. 15 Ο. Did you subsequently file a complaint 16 with the PSC upon behalf of North American Stainless? 17 Α. Yes. I, along with others, are listed 18 as counsel. 19 Q. All right, sir. And --20 Primarily relied upon -- I am not a --Α. Public Service Commission electrical rates are not 21 one of my areas of expertise. We used, and I'm sure 22 23 you have found out by now, Jay Brew and Smitty 24 Taylor. 25 Yes, sir. I have taken a statement Q.

from Mr. Taylor and due to take one from Mr. Brew. 1 2 Do you recall generally when the complaint was filed by North American Stainless? 3 September of '03, I believe. 4 Α. 5 Q , All right, sir. And subsequent to the 6 filing of the complaint, did KU file a tariff, the 7 tariff -- second one you mentioned in your prior 8 testimony? 9 Α. Yes, about a month later. 10 Q. All right, sir. Both of -- both the 11 complaint filed by North American Stainless and the 12 tariff involved KU, correct? 13 Correct. Α. 14 Ο. All right. There was no involvement 15 by LG&E; is that correct? 16 Α. No involvement from the standpoint of 17 the pleadings. As I'm sure you recognize, KU's letterhead also has LG&E. 18 19 Right. I was, obviously, aware of Ο. 20 that. Subsequent to the filing of the tariff, I trust you became aware of LG&E and KU petitioning for 21 22 a rate increase. 23 Α. Yes, I did. 24 Ο" Okay. And it's my understanding that 25 subsequent in time to the filing of the petition the

1 matters between North American Stainless and KU were 2 consolidated with the two rate cases. Am I correct? 3 Α. Yes. Ο. 4 Okay. 5 I think technically perhaps they were Α. consolidated with the KU docket number. 6 Thank you. Okay. And for ready 7 Q " reference, that would have been 2003-00434. 8 I believe that's correct. 9 Α. 10 All right, sir. Now, after the Ο. 11 consolidation, what role -- or what was your 12 participation in the consolidated case, 00434? 13 Α. Well, of course, I've conferred with -- with the clients and with co-counsel, Mr. Nat 14 15 Adams, Mr. Jay Brew and Smitty Taylor, and also my -my partner, Kim McCann, who was assisting me. 16 17 Ο. Do you have a recollection of having 18 had contact with the staff or employees of the Public 19 Service Commission? And the time frame is from the time the complaint was filed until April 28, 2004, 20 the date of the first informal conference here in 21 22 Frankfort, Kentucky. 23 No, I have -- I have no recollection. Α. 24 Q. Okay. And do I take it -- when I say "contact," that's either telephone, e-mail and/or 25

1 letter. 2 Α. That's correct. There were some pleadings -- I believe -- I believe NAS objected to 3 the consolidation. So if you consider formal 4 pleadings contact, that would be --5 6 Q. Fair enough. Other than that -- other than formal pleadings, no contact at least as far as 7 Bill Jones is concerned. 8 9 Α. Correct. 10 All right, sir. Did you come to Q. 11 Frankfort to attend the informal conference on 12 April 28, 2004? 13 April 28, 2004. I am not sure. Α. 14 Q. All right, sir. 15 Α. I think I was at a conference, a 16 prehearing conference on -- I thought it was 17 April 29th. 18 Q. April 28th, 2004, the informal 19 conference. And then May 3rd, 2004 was the 20 prehearing conference, just to fill in your knowledge of dates and times, because those are just benchmarks 21 22 here. May 3rd, 2004, prehearing conference. 23 May 4th, 5th and 6th were originally scheduled as 24 hearing dates, and some testimony was taken on those 25 dates. And there were negotiations that ensued also

1 on May 4th, 5th and 6th. Does that comport with your recollection? 2 3 I can't remember. I know that there A\_ were -- that I was at the PSC with -- with many 4 others prior to the beginning of the formal hearing, 5 but I can't recall the dates. 6 7 Q. Okay. Do you recall being there on 8 multiple days, Mr. Jones? 9 Α. Yes, although I was not there as -- on 10 every occasion that Mr. Taylor and Mr. Brew were 11 there, that I recall. But I'm sorry, I just cannot 12 recall the --13 All right. But you believe you were Q. 14 there on more than one day. 15 Α. Yes. 16 Q. And do I take it you participated in 17 the negotiation both with the rate case group as a whole and I take it also with individual issues 18 19 dealing with North American Stainless? 20 Α. Yes. 21 Q. Okay. Were you there on the first day 22 that negotiations began? Do you have a recollection of that? 23 24 Α. I do not know because I don't know the 25 date.

1	Q. All right. Fair enough. You do
2	the best you can do is that you can place yourself
3	there at the negotiation, but you don't know whether
4	it's the first day or what day?
5	A. That's correct.
6	Q. All right. And do you know that after
7	you arrived you were there to conclusion or do you
8	believe that you were only there for part of the
9	negotiation?
10	A. Well, when you say "negotiation," are
11	you my recollection is that we there was much
12	negotiation going on with many parties from the
13	standpoint of KU and LG&E, and we had to wait our
14	our turn, if you will, to have settlement discussions
15	with with KU and LG&E. And I don't remember how
16	many hours or days I was there. I believe I was
17	there on the evening where the parties and by "the
18	parties" I mean KU and NAS tentatively agreed to
19	changes in the nonconforming load tariff, which I
20	guess we could classify as a settlement, of course,
21	subject to the commission's approval.
22	Q. Okay. Do you believe you were there
23	for the settlement of all the other issues in the KU
24	and LG&E rate cases?
25	A. I I was there for I just can't

1 recall whether -- how many hours or days I was there 2 and how long the discussions --Okay. Fair enough. Let me ask you 3 Q. this. Did you have discussions or did you 4 5 participate in discussions with the PSC staff either the KU/LG&E rate case as a whole or on issues 6 on 7 dealing with the complaint and tariff of North American Stainless? 8 9 Α. I can remember that the parties were 10 basically given time to negotiate a settlement by the commission. The commission postponed the hearing. 11 Ι 12 can remember that NAS was asked to use a small 13 conference room adjacent to the lobby. The utility 14 had rooms in the back somewhere. I never knew exactly where. I know the attorney general was 1516 there. Representatives of others parties were there, 17 KIUC, et cetera. 18 And I can remember the staff -- vou would see a member of the staff in the hallway. I 19 20 don't remember any specific discussions about the merits, if you will, of any -- anyone's position. 21 Т can remember questions like, "How long do you think 22 23 you'll need us to stay here tonight?" I can even 24 remember one evening -- and I don't know whether it 25 was early in the evening or late in the evening --

the staff came by and said that they were leaving at 1 2 a specified time, maybe 10:00 p.m. or something. But 3 it would just be those general type discussions with the staff. 4 5 Ο. All right. So I take it nothing on 6 the merits of issues relating to North American 7 Stainless. 8 Α. Nothing that I can recall 9 participating in. 10And at any time in any of these Q. 11 proceedings -- and I'm talking about from the time of 12 the filing of the complaint until resolution, did 13 you -- did you have any communication with the 14 commission members themselves? 15Α. None. Okay. And did you ever -- same time 16 Q. 17 period. Did you have any communication with the 18 executive director, a Mr. Tom Dorman? 19 Α. Other than he would -- like other 20 members of the staff, he would be in the hallway and 21 just say hello. 22 All right, sir. Did you subsequently Q. 23 become aware of allegations by the attorney general 24 of collusion and ex parte communication during this 25 proceeding?

1 I came -- I became aware that the Α. 2 attorney general had raised issues of ex parte communication. I'm troubled by the word "collusion." 3 I'm not sure what it means, but I certainly know that 4 he raised issues about ex parte communication, yes. 5 6 Ο. All right, sir. And did you yourself, 7 with regard to the staff or commission members, observe anything which you believed to be an ex parte 8 9 communication? 10Α. No. 11 0. All right. And my definition of ex parte communication is any discussion on the 12 13 merits of the case or cases, as the case may be here, where persons -- all persons who had an interest were 14 15 not present. So discussions on the merits between 16 staff and/or the commissioners and anybody where all 17 other persons were not present. 18 Α. No. The -- the merits, if you will, 19 or the issues as to rates were discussed between NAS 20 and KU. And the staff did not participate in those 21 discussions. 22 MR. GOLDBERG: All right. Fair enough. Well, sir, that is all I have. I appreciate 23 24 your time. 25
