O R D E R

On May 11, 2005, Kentucky Utilities Company filed an application for approval of the construction of a transmission line in Jefferson, Bullitt, Meade, and Hardin counties, Kentucky. On May 23, 2005, the Commission issued a preliminary procedural schedule. Since issuance of that Order, numerous persons have requested a local hearing in this case. The Commission therefore finds that a hearing to receive public comments should be set in Elizabethtown, Kentucky, at 6:00 p.m., Eastern Daylight Time, on July 12, 2005. The location of the hearing will be set by a later notice from the Commission's Staff.

In light of the interventions and interest in this case, the Commission also finds that a hearing for cross-examination of witnesses should be scheduled for July 26, 2005, at the Commission's offices in Frankfort.

IT IS THEREFORE ORDERED that:

1. A local public hearing to receive public comments is scheduled for July 12, 2005 at 6:00 p.m., Eastern Daylight Time, in Elizabethtown, Kentucky.

2. A hearing for the purpose of cross-examining witnesses is scheduled for July 26, 2005, beginning at 9:00 a.m., Eastern Daylight Time, in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.

3. The attached revised procedural schedule shall apply.
