<u>ORDER</u>

On May 11, 2005, Louisville Gas and Electric Company ("LG&E") and Kentucky Utilities Company ("KU") jointly filed an application for approval of the construction of a transmission line in Jefferson, Bullitt, Meade, and Hardin counties, Kentucky. On May 23, 2005, the Commission issued a preliminary procedural schedule. On June 10, 2005, the Commission issued a revised procedural schedule setting the dates for hearings in this case, but that Order did not state the location for the hearing in Elizabethtown on July 12, 2005. The June 10, 2005 Order also referred to the applicant as KU alone rather than jointly with LG&E.

The Commission now sets the July 12, 2005 hearing at 6:00 p.m., Eastern Daylight Time, in the Pritchard Community Center, 404 South Mulberry Street, Elizabethtown, Kentucky. The Commission also, *nunc pro tunc*, changes the reference to the application of KU in the heading and the first line of text of the June 10, 2005 Order to the joint application of LG&E and KU.

IT IS THEREFORE ORDERED that:

1. The local public hearing to receive public comments, scheduled for 6:00 p.m., Eastern Daylight Time, on July 12, 2005, will be held at the Pritchard Community Center, 404 South Mulberry Street, Elizabethtown, Kentucky.

2. The reference to the application of KU in the heading and first line of text of the June 10, 2005, Order shall be changed, *nunc pro tunc*, to the joint application of LG&E and KU.

3. The attached revised procedural schedule shall apply.
