O R D E R

On August 11, 2005, Northern Kentucky Water District ("Northern District") filed a motion requesting an extension of time up to and including September 9, 2005, within which to respond to the Commission Staff's Second Information Request, dated July 29, 2005, and the First Request for Information by the Attorney General, dated July 27, 2005. Northern District stated that the extension is necessary due to limited staff, the consultant's schedule, and the volume of information requested.

Finding good cause to grant Northern District's motion, the Commission hereby amends the procedural schedule as set out in our Order of July 21, 2005. A revised procedural schedule is set forth in Appendix A, which is attached hereto and incorporated herein.

IT IS THEREFORE ORDERED that:

1. Northern District's request to extend the filing date for responses to data requests originally due on August 15, 2005 to September 9, 2005 is granted.

2. The procedural schedule set forth in Appendix A, which is attached hereto and incorporated herein, shall be followed and supersedes the previous schedule established in the Commission's July 21, 2005 Order.

3. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.

Northern District may file with the Commission the testimony of its rebuttal witnesses in written verified form no later than 11/23/05
