O R D E R

On July 1, 2005, East Kentucky Power Cooperative, Inc. ("East Kentucky Power") filed an application for approval of the construction of a transmission line in Barren, Warren, Butler, and Ohio counties, Kentucky. On July 12, 2005, the Commission ordered that the schedule for completion of the case be extended to 120 days and issued a preliminary procedural schedule. On July 14, 2005, the Commission issued a revised procedural schedule, but that Order did not fix a location for the hearing in Bowling Green on August 30, 2005. This Order makes two changes to that schedule.

First, the Commission now sets the August 30, 2005 hearing at 6:00 p.m., Central Daylight Time, in the auditorium at the Carroll Knicely Conference Center of Western Kentucky University, South Campus, 2355 Nashville Road, Bowling Green, Kentucky.

Second, Commission Staff's consultant was unable to meet with East Kentucky Power to exchange information in a timely enough manner to allow the consultant

sufficient time in which to prepare its report by the due date previously set by the Commission for August 4, 2005. The Commission now finds that the due date for the consultant's report should be extended to August 12, 2005, and that the due dates for data requests and responses be adjusted accordingly.

IT IS THEREFORE ORDERED that:

1. The local public hearing to receive public comments, scheduled for 6:00 p.m., Central Daylight Time, on August 30, 2005, shall be held in the auditorium at the Carroll Knicely Conference Center of Western Kentucky University, South Campus, 2355 Nashville Road, Bowling Green, Kentucky.

2. The revised procedural schedule, attached hereto as Appendix A, shall be followed in this case.
