ORDER

On July 1, 2005, East Kentucky Power Cooperative, Inc. (“Applicant”) filed an application for approval of the construction of a transmission line in Barren, Warren, Butler, and Ohio counties, Kentucky. On July 12, 2005, the Commission ordered that the schedule for the case be extended 120 days and issued a preliminary procedural schedule. On July 14, 2005, the Commission scheduled a local hearing to receive public comments on the application. The hearing was set for 6:00 p.m., Central Daylight Time, on August 30, 2005 in Bowling Green, Kentucky.

Given the prediction that the remnants of Hurricane Katrina will be hitting Bowling Green at the time the hearing is now scheduled, the Commission finds that the hearing should be rescheduled for the following week.

IT IS THEREFORE ORDERED that:

1. The August 30 local hearing is rescheduled to Tuesday, September 6, 2005, at 6:00 p.m., Central Daylight Time, in the Carroll Knicely Conference Center of

Western Kentucky University, South Campus, 2355 Nashville Road, Bowling Green, Kentucky.

2. A revised procedural schedule to be followed is attached as an Appendix to this Order. The Commission may modify this schedule by subsequent Order.
