ORDER

On June 17, 2005, Sandy Hook Water District (“Sandy Hook”) filed its application for Commission approval of proposed water rates. Commission Staff, having performed a limited financial review of Sandy Hook’s operations, prepared a Staff Report that the Commission issued in its Order of September 14, 2002. In that Order we allowed all parties 10 days in which to respond to the Staff Report. On September 19, 2002, Sandy Hook inquired about the absence of changes to certain non-recurring charges.

Commission Staff omitted these charges from its report. Staff has prepared an amended Attachment A, which is attached to this Order. All parties should review carefully the report, as amended, and provide any written comments or requests for a hearing or informal conference no later than 10 days from the date of this Order.

IT IS THEREFORE ORDERED that all parties shall have 10 days from the date of this Order to submit written comments regarding the amended Staff Report or requests for hearing or informal conference. If no request for a hearing or informal conference is received, this case stands submitted to the Commission for decision.
