ORDER

On October 27, 1998, in Case No. 1998-00244, the Commission approved rates for Sigma Gas Corporation ("Sigma") and provided for their further adjustment on a quarterly basis in accordance with Sigma's gas cost adjustment ("GCA") clause.¹

On September 12, 2005, Sigma filed its proposed GCA to be effective October 2, 2005. Sigma requests a waiver of the 30-day notice period. The city of Salyersville is now operating the Sigma system and is unfamiliar with the Commission's filing requirements; therefore, the operators were unable to file the GCA with a 30-day notice. As KRS 278.180 permits the Commission to shorten the required notice period for good cause, the Commission finds the request should be granted.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- Sigma's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Sigma's notice sets out an Expected Gas Cost ("EGC") of \$14.4904 per Mcf, which is \$6.7641 per Mcf more than the prior EGC of \$7.7263.

- 3. Sigma's notice sets out no current refund adjustment.
- 4. Sigma's notice sets out a current quarter actual adjustment ("AA") of (8.63) cents per Mcf. Sigma's notice includes a total AA of (15.81) cents per Mcf, which is an increase of 2.17 cents per Mcf from the previous total AA.
- 5. Sigma's notice sets out a current quarter balance adjustment ("BA") of (.75) cent per Mcf. The total BA of (8.72) cents per Mcf represents a decrease of 3.05 cents per Mcf from the previous total BA.
- 6. Sigma's gas cost recovery rate is \$14.2451 per Mcf, which is \$6.7553 per Mcf more than the previous rate of \$7.4898 per Mcf.
- 7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Sigma on and after October 2, 2005.

IT IS THEREFORE ORDERED that:

- 1. Sigma's request to shorten the period in which it must provide notice of the proposed adjustment from 30 days to 20 days is granted.
- 2. The rates in the Appendix, attached hereto and incorporated herein, are approved for billing for service rendered on and after October 2, 2005.
- 3. Within 20 days of the date of this Order, Sigma shall file with this Commission its revised tariff sheets setting out the rates approved herein.
