O R D E R

On November 22, 2005, Thoroughbred Generating Company, LLC (“Thoroughbred”), filed a Motion to Approve the Interconnection and Operating Agreement (“IOA”) between Thoroughbred and Big Rivers Electric Corporation (“Big Rivers”). The motion pointed out that the Public Service Commission has approved the IOA.<sup>1</sup> No party has filed opposition to granting the motion. On April 3, 2006, Thoroughbred filed a supplement to its motion, clarifying that its request for approval relates only to the relationship between Thoroughbred and Big Rivers.

Based on the filings in this case, the Board finds that the IOA should be approved. That approval, however, impacts only the relationship between Thoroughbred and Big Rivers. In an earlier Order, the Board said, “Thoroughbred shall hold Big Rivers, KU [Kentucky Utilities Company], and LG&E [Louisville Gas and Electric Company] harmless for costs of any and all interconnection and network

upgrade costs.”<sup>2</sup> This Order only approves that requirement insofar as it applies to Big Rivers.

IT IS THEREFORE ORDERED that:

1. The IOA complies with the requirements of KRS 278.212 with regard to the relationship between Thoroughbred and Big Rivers.

2. The IOA satisfies Condition K of our December 5, 2003 Order insofar as Thoroughbred and Big Rivers are involved.

3. The IOA otherwise complies with our December 5, 2003 Order with regard to the relationship between Thoroughbred and Big Rivers.
