ORDER

Northern Kentucky Water District (“NKWD”) has applied to the Commission for authority to construct various water main extensions, to finance the proposed project, and to implement a surcharge for the customers to be served by the extensions. In its filing, NKWD requested permission to deviate from certain filing requirements of Administrative Regulation 807 KAR 5:001, Section 6, which requires the submission of a detailed financial exhibit for the period ending not more than 90 days prior to the date of the application.

Specifically, NKWD has requested permission to deviate from Administrative Regulation 807 KAR 5:001, Sections 6(5), 6(6), 6(7), and 6(9). Section 6(5) requires that the financial exhibit disclose the amount of bonds authorized and the amount of bonds issued; Section 6(6) requires disclosure of each note outstanding; Section 6(7) requires disclosure of other indebtedness; and 6(9) requires the submission of a detailed income statement and balance sheet.

Administrative Regulation 807 KAR 5:001, Section 14, provides the Commission with the authority to permit deviations from its regulations for good cause shown.

Having reviewed the filing and being otherwise sufficiently advised, the Commission finds that the information required by the above-cited regulation is critical to the Commission's complete review of NKWD's filing. Therefore, NKWD will be required to comply with the requirements of the above-cited regulation.

NKWD's application contains a tariff with an effective date of August 1, 2006. However, the statutory time period in which the Commission must process this case will not commence until the above-mentioned information is filed with the Commission.

IT IS THEREFORE ORDERED that:

1. NKWD's request for permission to deviate from the filing requirements of Administrative Regulation 807 KAR 5:001, Sections 6(5), 6(6), 6(7) and 6(9), is denied.

2. Within 15 days from the date of this Order, NKWD shall file with the Commission the information required by Administrative Regulation 807 KAR 5:001, Sections 6(5), 6(6), 6(7), and 6(9).

3. The statutory time period in which the Commission must process this filing will not commence until the information required by Ordering Paragraph 2 is filed with the Commission. When NKWD files such information, it may re-file its tariff with a new proposed effective date that is at least 30 days from the date the information is filed.
