ORDER

On November 10, 2004, in Case No. 2004-00067,<sup>1</sup> the Commission approved rates for Delta Natural Gas Company, Inc. (“Delta”) and provided for their further adjustment in accordance with Delta’s gas cost adjustment (“GCA”) clause.

On June 23, 2006, Delta filed its proposed GCA to be effective July 25, 2006.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Delta’s notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Delta’s expected gas cost (“EGC”) is \$8.8906 per Mcf, which is 49.01cents per Mcf less than the previous EGC of \$9.3807.
3. Delta’s notice sets out a current quarter refund adjustment (“RA”) of (.03) cent per Mcf. Delta’s notice sets out a total RA of (.06) cent per Mcf, which represents a decrease of .03 cent per Mcf from the previous total RA.

4. Delta's notice sets out a current quarter actual adjustment ("AA") of (\$2.1650) per Mcf. Delta's total AA is 62.7 cents per Mcf, which is a decrease of \$2.2556 per Mcf from the previous total AA.

5. Delta's notice sets out a balance adjustment ("BA") of \$1.4398 cents per Mcf, which represents an increase of \$1.8266 per Mcf from the previous BA.

6. Delta's GCA is \$10.9568 per Mcf, which is 91.94 cents per Mcf less than the previous GCA of \$11.8762.

7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for final meter readings by Delta on and after July 25, 2006.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix to this Order are approved for final meter readings on and after July 25, 2006.

2. Within 20 days of the date of this Order, Delta shall file with this Commission its revised tariffs setting out the rates authorized herein.
