On May 18th that access number became long distance without our knowledge and huge long distance charges were billed to us. From May 18th to June 6th we were unaware these charges were being incurred.


I buy and sell on Ebay and spend many hours on the internet. When the first bill arrived on June 6th, I tried to get some help from AT&T, they were rude and nonresponsive, to say the least. We finally cancelled their service on June 12th.

Our questions are simple and our request small. How can a person turn on their computer and have access to the internet every day for over a year and pay only \$14.95 a month for this service and then all of a sudden be expected to pay outrageous charges for the same service they have enjoyed up until May 18th.

We ask only for relief from the excessive long distance charges for only using our internet service that we had a history of trusting. We were totally unaware long distance charges were being totaled on our bill and nothing was ever done to make us aware that this could happen to us.
