O R D E R

On July 2, 2007, East Kentucky Power Cooperative, Inc. ("EKPC") filed a motion seeking an additional postponement of the filing date for Intervenor testimony. Pursuant to the revised procedural schedule issued on June 29, 2007, the filing of Intervenor testimony was due on July 5, 2007. EKPC requests that the filing of Intervenor testimony be postponed until July 11, 2007. In support of its motion, EKPC states that the Intervenor and EKPC have been involved in settlement discussions and that EKPC, the Attorney General ("AG"), and Kentucky Industrial Utility Customers, Inc. ("KIUC") have reached tentative agreement on major elements of a settlement proposal for this case. EKPC notes that delays have been encountered in completing the final review and approval of the proposed settlement terms, which the AG and KIUC anticipate filing as part of Intervenor testimony. EKPC states the Sierra Club filed its testimony on June 29, 2007, and has indicated it may not enter into the proposed settlement. EKPC, the AG, and KIUC believe an agreement may be reached in the near future. Thus EKPC, in accord with the AG and KIUC, is requesting the additional postponement and further states EKPC would not request further extensions of the remainder of the procedural schedule if no settlement is reached.

The Commission finds EKPC has provided good cause to support its request for an additional postponement. However, granting EKPC's request will require that other dates in the June 29, 2007 procedural schedule be changed. The Commission hereby amends the procedural schedule of June 29, 2007 and adopts the schedule included in Appendix A, attached hereto and incorporated herein.

IT IS THEREFORE ORDERED that the procedural set forth in Appendix A shall be followed in this case.
