O R D E R

Having reviewed the application of Kentucky-American Water Company ("Kentucky-American") and the initial rounds of discovery in this proceeding and finding that the scope and complexity of the issues presented require greater time for review and analysis than originally allowed, and further finding that public hearings for the purpose of receiving public comment on the proposed construction should be held, the Commission, on its own motion, HEREBY ORDERS that:

1. The procedural schedule set forth in the Appendix to this Order is substituted for and replaces the procedural schedule set forth in the Appendix to our Order of April 20, 2007.

2. Public hearings for the sole purpose of receiving public comment on the proposed construction shall be held on September 10, 12, and 13, 2007. Kentucky-American shall give notice of these hearings in accordance with Administrative Regulation 807 KAR 5:011, Section 8(5). At the time publication is requested, it shall forward a duplicate of each notice and request to the Commission.

3. All provisions of the Commission's Order of April 20, 2007 that do not conflict with this Order shall remain in full force and effect
