Charles Ferguson and Steve Cruce, Magistrates of the Lyon County Fiscal Court, ("Magistrates"), pursuant to 807 KAR 5:001, are to file with the Commission the original and 8 copies of the following information, with a copy to all parties of record. The information requested herein is due on or before 15 days from the date of this request. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry. Magistrates shall make timely amendment to any prior responses if they obtain information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any requests to which Magistrates fail or refuse to furnish all or part of the requested information, Magistrates shall provide a written explanation of the specific grounds for their failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

1. Provide the <u>curriculum vitae</u> of Charles M. Murphy.

2. State Mr. Murphy's date of birth.

3. State Mr. Murphy's current address.

4. State whether Mr. Murphy has been convicted of violating any law (other than minor traffic offenses). If yes, list the conviction, date, and place.

5. State whether Mr. Murphy resides in Lyon County Water District's ("Lyon District") territory, which could be different from residing in Lyon County.

6. State whether Mr. Murphy is currently a customer of Lyon District. If yes, provide a copy of a recent billing statement to him from Lyon District.

7. Describe Mr. Murphy's educational background.

8. Describe Mr. Murphy's experience in operating or managing a water utility.

9. Describe Mr. Murphy's experience in managing or operating organizations similar to a water utility.

10. List all positions that Mr. Murphy currently holds with any local, state, or federal governmental entity.

11. State whether Mr. Murphy has ever entered into any contract with Lyon District to provide goods or services. If yes, provide a copy of each contract.

12. List all business transactions that Mr. Murphy has had with Lyon District in a personal or non-official capacity.

13. List all courses of water district management training that Mr. Murphy has attended since January 1, 2002.

14. Describe any ethics training Mr. Murphy has attended since January 1, 2002 for government/public officials.

15. Provide a map of Lyon District's territory and the ordinances of the Lyon County Fiscal Court and orders of the Lyon County Judge/Executive that established these territorial boundaries.
