## ORDER

On May 31, 1996, in Case No. 1994-00433, the Commission approved rates for Bluegrass Gas Sales, Inc. ("Bluegrass") and provided for their further adjustment on a quarterly basis in accordance with Bluegrass's Gas Cost Adjustment ("GCA") clause.<sup>1</sup>

On August 31, 2007, Bluegrass filed its proposed GCA to be effective October 1, 2007.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

- 1. Bluegrass's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
- 2. Bluegrass's notice sets out an Expected Gas Cost ("EGC") of \$8.8085 per Mcf, which is a decrease of \$1.5429 per Mcf from its previous EGC of \$10.3514.
- 3. Bluegrass's notice sets out no current quarter Refund Adjustment ("RA"). Bluegrass's notice sets out no total RA.

4. Bluegrass's notice sets out a current quarter Actual Adjustment ("AA") of

(7.21) cents per Mcf. Bluegrass's total AA is (\$1.1857) per Mcf, which is an increase of

25.05 cents per Mcf from its previous total AA.

5. Bluegrass's notice sets out a current quarter Balance Adjustment ("BA") of

4.86 cents per Mcf. Bluegrass's total BA is 14.53 cents per Mcf, which is an increase of

8.39 cents per Mcf from its previous total BA.

6. Bluegrass's Gas Cost Recovery Rate is \$7.7681 per Mcf, which is a

decrease of \$1.2085 per Mcf from its previous rate of \$8.9766.

7. The rates in the Appendix to this Order are fair, just, and reasonable, and

should be approved for billing for service rendered by Bluegrass on and after October 1,

2007.

IT IS THEREFORE ORDERED that:

1. The rates in the Appendix, attached hereto and incorporated herein, are

approved for billing for service rendered on and after October 1, 2007.

2. Within 20 days of the date of this Order, Bluegrass shall file with the

Commission its revised tariffs setting out the rates approved herein.
