ORDER

On December 2, 1999, in Case No. 1999-00312,¹ the Commission approved rates for Millennium Energy, Inc. (“Millennium”) and provided for their further adjustment in accordance with Millennium’s Gas Cost Adjustment (“GCA”) clause.

On June 23, 2008, Millennium filed its proposed GCA to be effective August 1, 2008.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Millennium’s notice includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Millennium’s notice sets out an Expected Gas Cost (“EGC”) of \$12.5101 per Mcf, which is an increase of \$2.8198 per Mcf from its previous EGC of \$9.6903.
3. Millennium’s notice sets out no Refund Adjustment.

4. Millennium's notice sets a current quarter Actual Adjustment ("AA") of \$.5300 per Mcf. Millennium's total AA is \$1.4456 per Mcf, which is \$1.5179 per Mcf more than the previous total AA.

5. Millennium's notice sets out a current quarter Balance Adjustment ("BA") of \$.0319 per Mcf. Millennium's total BA is \$.0388 per Mcf, which is \$.0342 per Mcf more than the previous total BA.

6. Millennium's Gas Cost Recovery Rate is \$13.9945 per Mcf, which is \$4.3719 per Mcf more than the previous rate of \$9.6226.

7. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for service rendered by Millennium on and after August 1, 2008.


IT IS THEREFORE ORDERED that:
