ORDER

On October 10, 1986, in Case No. 9565,¹ the Commission approved rates for Public Gas Company (“Public”) and provided for their further adjustment in accordance with Public’s Gas Cost Adjustment (“GCA”) clause.

On July 1, 2008, Public filed its proposed GCA to be effective August 1, 2008.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Public’s notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. Public’s proposed Expected Gas Cost (“EGC”) is \$13.6079 per Mcf, which is an increase of \$2.9951 per Mcf from the previous EGC of \$10.6128.
3. Public’s notice sets out no current quarter Refund Adjustment.
4. Public’s notice sets out a current quarter Actual Adjustment (“AA”) of \$.4228 per Mcf. Public’s notice sets out a total AA of \$.4519 per Mcf, which is an increase of \$.0382 per Mcf from the previous total AA.

5. Public's GCA is \$14.0598 per Mcf, which is \$3.0333 per Mcf more than the previous GCA of \$11.0265.

6. The rates in the Appendix to this Order are fair, just, and reasonable, and should be approved for billing for service rendered by Public on and after August 1, 2008.


IT IS THEREFORE ORDERED that:

2. Within 20 days of the date of this Order, Public shall file with this Commission its revised tariffs setting out the rates authorized herein.
