On July 11, 2008, Bronston Water Association (“Bronston”) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Bronston purchases water from Monticello Utility Commission (“Monticello”).
2. Monticello notified Bronston that, effective with its June 26, 2008 billing, the wholesale rate would increase from \$2.02 per 1,000 gallons to \$2.40 per 1,000 gallons.
3. Bronston proposes a purchased water adjustment factor of \$0.58 per 1,000 gallons.
4. During the 12-month period ending April, 2008, Bronston purchased 113,691,800 gallons of water. It sold 75,115,876 gallons of water during the same period. The increase in the cost of purchased water is \$43,202.88, resulting in a purchased water adjustment factor of \$0.58 per 1,000 gallons.

5. On June 2, 2008, Bronston's Board of Directors approved an increase in its rates to its customers effective June 26, 2008 to reflect the increase in Monticello's wholesale rate.

6. The purchased water adjustment factor of \$0.58 per 1,000 gallons is fair, just, and reasonable and should be approved.


IT IS THEREFORE ORDERED that:

1. The rates proposed by Bronston are approved.
2. The purchased water adjustment factor of \$0.58 per 1,000 gallons as calculated in Appendix A, which is attached hereto and incorporated herein, is approved.
3. The rates in Appendix B, which is attached hereto and incorporated herein, are fair, just, and reasonable and are approved for service provided on or after June 26, 2008.
4. Within 20 days of the date of this Order, Bronston shall file with the Commission revised tariff sheets showing the rates approved herein.
