ORDER

KRS 74.020(7) requires that this Commission "encourage and promote the offering of high quality water district management training programs that enhance a water district commissioner's understanding of his or her duties." Pursuant to this statutory mandate, the Commission, in association with the Kentucky Rural Water Association, has conducted or will shortly conduct training seminars at Lake Barkley State Resort Park, Lake Cumberland State Resort Park, and Jenny Wiley State Resort Park. These seminars included instruction regarding, inter alia, trends in applicable law and regulations, utility rate-making, management, finance, and administration.¹

Based upon a review of the course curriculum, the Commission finds that:

1. The courses of instruction provided at these seminars would enhance a water district commissioner's understanding of his or her duties.


2. The seminars conducted at Lake Barkley State Resort Park, Lake Cumberland State Resort Park, and Jenny Wiley State Resort Park should be approved for 12 credit hours of water district management training.

IT IS THEREFORE ORDERED that the 2008 Water Personnel Training Seminars, which the Commission, in association with the Kentucky Rural Water Association, conducted or will conduct on September 10-11, 2008 at Lake Barkley State Resort Park, on September 23-24, 2008 at Lake Cumberland State Resort Park and on October 15-16, 2008 at Jenny Wiley State Resort Park, are approved for a maximum of 12 credit hours.
