O R D E R

On September 24, 2008, Muhlenberg County Water District #3 ("Muhlenberg District #3") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Muhlenberg District #3 purchases water from the city of Central City ("Central City").
2. Central City notified Muhlenberg District #3 that, effective September 20, 2008, Central City's wholesale water rate to Muhlenberg District #3 would increase from \$1.25 per 1,000 gallons to \$1.57 per 1,000 gallons. Muhlenberg District #3 proposes to increase the water rates to its customers effective November 1, 2008.
3. Muhlenberg District #3's application contained a mathematical error in the computation of the purchased water factor and the proposed rates.

4. During the 12 months ending August 31, 2008, Muhlenberg District #3 purchased a total of 269,877,130 gallons of water and sold 224,134,100 gallons. The increase in the cost of purchased water is \$86,360, resulting in a purchased water adjustment of \$0.39 per 1,000 gallons.

5. The purchased water adjustment of \$0.39 per 1,000 gallons is fair, just, and reasonable and should be approved.


IT IS THEREFORE ORDERED that:

1. Muhlenberg District #3's proposed rates are denied.
2. The purchased water adjustment of \$0.39 per 1,000 gallons as calculated in Appendix A is approved and the rates in Appendix B, attached hereto and incorporated herein, are fair, just, and reasonable and are approved for services rendered on and after November 1, 2008.
3. Within 20 days of the date of this Order, Muhlenberg District #3 shall file with the Commission revised tariff sheets showing the rates approved herein.

All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of the Commission prior to the effective date of this Order.
